

Suspect Wanted for Two Commercial Armed Robberies

Up to \$1,000 Reward Offered

San Diego County Crime Stoppers along with investigators from the San Diego Police Department's Robbery Unit are asking for the public's help in identifying and locating an unknown suspect responsible for two commercial armed robberies. Investigators believe the same suspect is responsible for both robberies.

On September 15, 2019, at 3:05 a.m., an unknown male suspect entered the Subway restaurant located at 3308 University Avenue, in San Diego. The suspect jumped over the counter and pointed a black revolver at the employee while he demanded money. The employee complied and opened the cash register. The suspect took an undisclosed amount of cash and was last seen running westbound on University Avenue.

On September 18, 2019, at 6:55 a.m., an unknown male suspect entered the Subway restaurant located at 1722 Euclid Avenue, in San Diego. The suspect pointed a black revolver at an employee and demanded money. The suspect told the employee to "hurry up" in Spanish. The suspect spoke English during the initial demand. The employee complied and gave the suspect an undisclosed amount of cash. The suspect was last seen running southbound away from the business.

Suspects' Description:

The suspect is described as a Hispanic male, mid 20's, 5'6" to 5'8" tall, thin build and shaved head. In the 9/15/2019 case, the suspect was wearing a black mask, black gloves, black hooded sweatshirt with white stripes along the arms, dark pants, black tennis shoes, and was carrying a black revolver.

In the 9/18/2019 case, the suspect was wearing a blue hooded sweatshirt with a grey colored chest and grey hoodie, blue shorts, black shoes, black mask, black gloves, and was carrying a black revolver. The suspect has a tattoo on the inside of his right wrist.
