Unknown Suspects Wanted for Robbery

Up to \$1,000 Reward Offered

November 10, 2022

San Diego County Crime Stoppers and investigators from the San Diego Police Department's Central Division are asking for assistance from the public to help identify and locate the suspects responsible for robbing a victim of their cell phone and assaulting three other victims in the East Village area.

On October 14, 2022, at about 10:53 p.m., three unknown suspects got into an argument with two other males in the 1100 Block of J Street, in San Diego. During the argument, the suspects punched two of the victims in their face causing both to fall to the ground. While on the ground, the suspects kicked both victims in their face causing both to lose consciousness. A 60-year-old male saw what was happening and attempted to stop the suspects from kicking the victims. The suspects then began to punch the 60-year-old male in his head causing him to fall to the ground and strike his head on the concrete. A person nearby used their cell phone and tried calling 911. One of the suspects then stole that person's cell phone.

The three victims suffered numerous injuries due to being kicked multiple times in their head. These injuries include a skull fracture, broken nose, and broken orbital.

Suspects' Description:

Suspect # 1 is described as a Black male, 25 to 30-years-old, tall, thin build, afro hairstyle, wearing a black t-shirt, black jeans, and white shoes with a black stripe on them.

Suspect # 2 is described as a Black male, 25 to 30-years-old, tall, thin build, wearing a black t-shirt, gray jeans, and black shoes.

Suspect # 3 is described as a Black male, light complexion, approximately 30-years-old, tall, heavy build, full beard, wearing a tan Padres "Tony Gwynn" jersey, black pants, and white shoes.
